# **INITIAL CORNER WHEN READ**

### **ARENA SETUP**

Rental prices are for normal configuration of the arena fence and grounds prepared in normal good show condition. Any special requests for different equipment, configuration or grounds will be subject to extra charges. Work lights will be available during setup and practice. Show lights will be used for show time only. Please turn off the arena light and overhead fans any time your event is not in progress. Lights & Fans left on over night are subject to a \$50 per hour charge.

## STALLS / RV / SHAVINGS

Only the actual number of bales, stalls and electrical hook-ups used will be charged. Set up day will allow access to the arena after 5:00 PM. If no other events are booked earlier access may be allowed but not guaranteed. Please do not stall horses in the livestock pens. Stalls are available for use and a back charge will be invoiced for any horses kept in these pens. Damage to stalls will be billed to the renter.

### **INSURANCE**

Renter shall carry general liability insurance against Bodily injury, personal injury and property damage for the duration of this contract in the amount of not less than One Million Dollars (\$1,000,000) combined single limit per occurance. A certificate of insurance naming the Celebration Centre LLC and Bar K Bar Arena as an additional insured must be provided no later than 30 days prior to the first date of occupancy.

Celebration Centre LLC prohibits the use of smoking inside the Arena building. No sale of alcohol is allowed on the premises without prior approval and appropriate permits. All beverages are to be consumed within the Bar K Bar Arena building. No outside food or tack vendors are allowed to sell on premise without prior consent.

### **KEYS**

Keys will be provrided for entrance into the Show Office, Commons and electrical panel as needed. Lost keys will have a replacement charge of \$25. Replacement costs will be charged to the Renter for any damaged or stolen furniture or artwork. The show office and restroom is a public space. It may have traffic through to the Farm Bureau Conference room, restroom, employee office as well as the tack store. Which also includes multiple People having keys and access. If you require a secure location, please inquire on Conference Room rental.

# **HOUSEKEEPING**

**VENDORS** 

It is the responsibility of the Renter to pick up all bottles, cans and trash inside the arena and in parking lots and placed in the trash dumpsters. The renter will be charged a cleaning fee of \$200.00 if the Celebration Centre LLC have to clean the area. Any damages to the buildings or grounds are the responsibility of the Renting group or Individual. All dogs are required to be on a leash in the Arena and on the grounds. No dogs except Certified Service Dogs are allowed in the Commons per 2005 Kansas Food Code: 6-501.115 Prohibiting Animals.

# **CANCELLATIONS**

Events cancelled more than 60 days before the event will not be charged a fee. Events cancelled less than 60 days before the first day of the event will be charged ONE days Arena Rent if not rescheduled within the calendar year.

# **PAYMENT**

All rent / stall / RV / shavings etc. due to the Bar K Bar Arena are due and payable to he Celebration Centre LLC on the last day of the event for these contract dates. NO EXCEPTIONS!
